

**ADMISSION NOTICE**

**Public Sector Medical/Dental Colleges**

Applications are invited for admission in Public Sector Medical / Dental colleges, Govt. of Khyber Pakhtunkhwa, session 2018-19, from candidates who meet the eligibility criteria. The prospectus will be available on payment of Rs.2000/- from the following branches of **National Bank of Pakistan:-**

1. University Campus, Saddar Road & G.T Road Branches in Peshawar.
2. Main branch Abbottabad.
3. Main branch D.I.Khan.
4. Main branch Saidu Sharif, Swat.
5. Main branch Mardan.
6. Main branch Bannu.

**Eligibility**

1. The candidates having obtained 60% unadjusted marks in their F.Sc (Pre-Medical) or other equivalent qualification from Board of Intermediate and Secondary Education in Pakistan or abroad.
2. The candidates who have appeared in the Entrance Test held in 2018.
3. The candidates having domicile of Khyber Pakhtunkhwa / FATA / Gilgit Baltistan (Northern Areas)/ AJK.

**Note**


1. The application forms in original shall be submitted **by hand** to Chairman Joint Admission Committee, Khyber Medical College Peshawar, **during duty hours on all week days.**
2. **No forms will be accepted through mail/courier.**
3. All application must be complete from all aspect at the time of submission.
4. Incomplete application will not be entertained.
5. No documents will be accepted after the last date of application.
6. FATA candidates shall submit Admission forms in original to Khyber Medical College, Peshawar and a photocopy of the same to FATA Secretariat, Warsak Road Peshawar.
7. FATA inner & Backward area candidates shall submit certificates of location of institutes as per specimen given in the prospectus without which the forms will not be accepted.
8. A candidate will give his/her preference in order of priority for the medical / dental colleges in the designated space provided in the Admission Form which once given shall be final and cannot be changed subsequently. This condition is mandatory and neither any subsequent change is entertainable nor any exceptions will be made. The candidate shall be considered only for those colleges for which he/she has shown their preference. A candidate, under no circumstances, will be considered for a college not listed in his/her preferences.
9. The interviews for the Open Merit seats will be conducted at the respective colleges, whereas the interviews for the rest of the category seats will be conducted at Khyber Medical College, Peshawar.
10. Candidates selected on any category seat will have to deposit their fee on the same day of receiving the admission letter, failing which the candidate next in merit list will be considered, to facilitate early completion of admission process and commencement of classes.
11. Place of Domicile entered in the online registration form on KMU website and the one produced with the admission form must be the same, otherwise the candidate shall be deemed **disqualified.**
12. List of candidates for allocation of seats in respective medical colleges on merit cum choice along with final Joint Merit list will be displayed on the college notice board and website [www.kmc.edu.pk](http://www.kmc.edu.pk).
13. After the closing date for admissions no admission on any category seat or change from one category to another will be entertained.
