	<p>Management Committee reviewed minutes of MC meetings held on 21<sup>st</sup> July 2017, 12<sup>th</sup> August 2017, 7<sup>th</sup> October 2017, 14<sup>th</sup> October 2017, 15<sup>th</sup> December 2017, 5<sup>th</sup> November 2018, 28<sup>th</sup> March 2019 and 30<sup>th</sup> May 2019 and observed that none of its decisions have been implemented.</p> <p>The following decisions were taken;</p> <p><b>Consultants:</b></p> <ul style="list-style-type: none"><li>• All those consultants who have not given option to IBP shall not be allowed to sit in IBP. They shall immediately vacate space provided.</li><li>• All new faculty recruitments shall be provided space for IBP.</li><li>• All those who have given option and have decided to sit in IBP without incentives must stop attending to their private clinics outside hospital failing which disciplinary action shall be taken including termination of their services.</li></ul>
