2. Single stage single envelope procedure as mentioned in KPPRA rule 2 (a) of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014 shall apply.
3. Bidding documents containing detailed terms & conditions can be obtained from Directorate of Works KMC upon written request on their printed pads on payment till closing date. The delay and delivery of the tender documents will be the responsibility of contractors. No application will be entertained after due date & time.
4. The firms / contractors are requested to furnish the following information/documents with their sealed tenders/bids:
 - a) Photocopy of updated renewal receipt & registration with C&W Department for the year 2022-23.
 - b) Photocopy of registration with PEC valid up to last date of calendar Year.
 - c) Photocopy of Computerized National Identity Card (CNIC).
 - d) Photocopy of registration with FBR (Active Status)
 - e) Photocopy of registration with KPRA (Active Status)
 - f) Fresh affidavit on stamp paper **properly attested by the Oath Commissioner**, to the effect that the firm has never been black listed by any Agency / Department and also not involved in any subversive activities.
 - g) Bank statement for the last three years.
5. All bidders must submit their bid security / CDR as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22/6058-71 dated 10/05/2022 otherwise the bid shall be considered as non-responsive.
